**Subject:** FY 2023 GYCC Project Selections

I am pleased to announce the projects selected by the Greater Yellowstone Coordinating Committee (GYCC) to receive funding for fiscal year 2023. Five projects were submitted and are approved for funding in amounts ranging from \$6,000 to \$89,000, for a total of \$170,000. One additional project, a GYE resource assessment, will be funded at \$80,000, for a total of \$250,000 in project support this year. These awards are contingent on actual FY23 agency budgets.

In FY23, the GYCC executives made final decisions after reviewing proposals using the following criteria:

- How well does the project address GYCC priorities (see below)?
- To what extent does the project build external partnerships and leverage funds?
- To what extent does the project result in internal partnerships between units or result in wide-scale benefits for the Greater Yellowstone Area?
- How well does this project increase public awareness of the cross-boundary coordination of the GYCC and subcommittees?

Proposals were considered for their relevance to the GYCC Strategic Priorities:

#### 1. Maintain Resilient Landscapes within the Greater Yellowstone Ecosystem

- Understanding and Responding to Climate Change
- Combatting Nonnative Species
- Improving and Maintaining Ecosystem and Wildlife Health

- Developing Cross-Boundary Solutions that Improve Recreational and Visitor Experiences
- Sharing Best Practices

#### 3. Strengthen Coalitions, Partnerships and Communications

- Improving Communication and Support within the GYCC

I will work with subcommittee chairs and project leads to facilitate fund transfers, agreements, and other necessary documentation needed to make funds available for each project.

Thank you to all who prepared submissions this year on short notice as we shift to a new project proposal process. We look forward to the results of the 2023 GYCC projects.
